

## GREENVIEW VILLAGE BOARD MINUTES

Of May 2<sup>nd</sup>, 2022

The Greenview Village Board met for a regular scheduled board meeting on Monday May 2<sup>nd</sup>, 2022. ### **Public Participation:**
