

**GREENVIEW VILLAGE BOARD MINUTES
Of November 21st, 2022**

The Greenview Village Board met for a regular scheduled board meeting on Monday November 21st, 2022. President Curry called the meeting to order at 7:00 p.m. and all present participated in the pledge of allegiance. The roll call indicated that Trustees Pamela Rouse, Taya Smith, Elizabeth Soldwedel, Norman Hofmann, and Pat Feagans were present. Other village personnel present were Village Treasurer John Holt, Police Chief Alex Thomson, and Village Clerk Monica Brumm.

Public Participation:

A representative from Estes, Bridgewater, Ogden was present to give the findings for the 2021/2022 Audit.

Alex Thomson gave the police report. A motion was made by Trustee Hofmann and seconded by Trustee Soldwedel to accept the police report. All present in favor voted aye. Report filed into record.

John Holt gave the treasurer's report. A motion was made by Trustee Soldwedel and seconded by Trustee Rouse to accept the treasurer's report. All present in favor voted aye. Report filed into record.

John Holt gave the zoning report. A motion was made by Trustee Feagans and seconded by Trustee Hofmann to approve the zoning report. All present in favor voted aye. Report filed into record.

The minutes from the November 7th, 2022, board meeting was reviewed by each board member. A motion made by Trustee Rouse and seconded by Trustee Feagans to approve the minutes. Minutes approved and filed into record.

Income/Expense/Bill Report Each board member reviewed the bills. A motion was made by Trustee Rouse and seconded by Trustee Hofmann to approve the payment of all bills. Motion was roll called, all present voted aye. Motion passed.

Old Business-

1. A motion was made by Trustee Feagans and seconded by Trustee Smith to approve the 2023 meeting schedule. All present voted aye. Motion carried.

At 7:27 pm a motion was made by Pat Feagans and seconded by Elizabeth Soldwedel to move into executive session to discuss employee matters. The executive session ended at 8:05 pm.

New Business-

1. A motion was made by Trustee Feagans and seconded by Trustee Hofmann to approve Ordinance #563 – TAX LEVY OF THE VILLAGE OF GREENVIEW ILLINOIS FOR THE CORPORATE YEAR BEGINNING MAY 1, 2022, AND ENDING THE 30TH DAY OF APRIL 2023. Motion was roll called all present in favor voted aye. Motion Carried.
2. A motion was made by Trustee Hofmann and seconded by Trustee Smith to approve Ordinance #564 – TAX LEVY OF THE VILLAGE OF GREENVIEW ILLINOIS ROAD DISTRICT NO 14, FOR THE CORPORATE YEAR BEGINNING MAY 1, 2022, AND ENDING THE 30TH DAY OF APRIL 2023. Motion was roll called all present in favor voted aye. Motion carried.
3. A motion was made by Trustee Rouse and seconded by Trustee Soldwedel to approve Ordinance #565 – AMENDING ORDINANCE NO #147, #153, #285, #289, #300, #343, #373, #374, #458, #486, #498, #506, #545, #546 AND #562 REGULATING THE SALE, PURCHASE, AND CONSUMPTION OF

ALCOHOLIC BEVERAGES IN THE VILLAGE OF GREENVIEW, ILLINOIS, THE LICENSING AND REGULATION FOR RETAIL SALE THEREOF IN SAID VILLAGE: AND PROVIDING PENALTY FOR VIOLATION THEREOF. Motion was roll called, all present in favor voted aye. Motion carried.

4. A motion was made by Trustee Smith and seconded by Trustee Rouse to approve raises for street and water department employees. Motion was roll called, all present in favor voted aye. Motion carried.

Committee Reports:

Trustee Feagans: Got pricing on a blade for the tractor. The bid was \$3800 for blade, hydraulics, and snowshoes. A motion was made by Trustee Feagans and seconded by Trustee Hofmann to put on the next meeting agenda to vote to purchase.

Trustee Hofmann: Reported how other communities handle the military plaques and pricing. Advised that a grant opportunity with the IEPA was available and paperwork was submitted. Advised that the school had spirit signs

Trustee Soldwedel: Continues to update website.

Trustee Booth: Absent

Trustee Smith: Volunteer Park committee raised approximately \$300 with the paw print fund raiser. They are discussing new equipment and tire swing and possible things to do for Christmas celebration.

Trustee Rouse: Advised board that repair on the tractor windshield had been filed with the insurance.

Clerk: Advised that would need to be getting shirts for Steve and Joe at the beginning of the year and would like to see about changing logo. Showed pictures of logo ideas. Was discussed and will remain with the current logo.

President: Gave Trustee Booth's committee report regarding 1 oak tree to be trimmed and stumps will be contacting tree service for dates. Advised that received estimate on getting heat to the storage room at the back of Village Hall. Received two quotes one would use our existing duct work, the other would be a 12,000 BTU mini split. Will put it on the next meeting agenda for a vote.

The meeting adjourned at 8:40 pm.

At the conclusion of all business, the announcement of the next meeting was made. The next meeting will be held on Tuesday December 5th, 2022, at 7:00 pm.
