ORDINANCE AMENDING ORDINANCE NO #147, #153, #285, #289, #300, #343 #373, #374 #458, #486, #498, #506 and #545 REGULATING THE SALE, PURCHASE AND CONSUMPTION OF ALCOHOLIC BEVERAGES IN THE VILLAGE OF GREENVIEW, ILLINOIS, THE LICENSING AND REGULATION FOR RETAIL SALE THEREOF IN SAID VILLAGE: AND PROVIDING PENALTY FOR VIOLATION THEREOF

WHEREAS, the Village of Greenview, Menard County, Illinois, has the power and jurisdiction to regulate the sale, use and consumption of alcoholic beverages inside the corporate limits of the Village of Greenview; and

WHEREAS, the Village Board of Trustees of the Village of Greenview, State of Illinois, has previously enacted certain ordinances and resolutions regulating the sale, use and consumption of alcoholic beverages; and

WHEREAS, the Board of Trustees of the Village of Greenview find that such ordinances and resolutions heretofore adopted should be amended.

NOW THEREFORE BE IT ORDAINED, by the Village Board of Trustees, of the Village of Greenview and State of Illinois, as follows:

AMENDMENT TO #458 ARTICLE I GENERAL, SECTION 3 entitled " HOURS DAYS OF SALE REGULATED" Section 3 shall be hereafter amended to provide as follows:


Holders of all liquor licenses shall be allowed to sell alcohol Monday through Saturday from 8:00 a.m. to 12:00 a.m. and Sunday from 11:00a.m. to 8:00 p.m. Alcohol shall not be sold by any holder of a liquor license other than the hours specifically listed herein.

BE IT further ordained by the Village Board of Greenview, Menard County, Illinois that this

Ordinance No 562 amending #147, #153, #285, #289, #300, #343 #373, #374 #458, #486, #498, #506 and #545 inclusively shall be in full force and effect 30 days from and after its passage, approval and publication according to law. Upon passage the Village of Greenview Clerk is directed to mail a copy of this Ordinance to each individual currently holding a liquor license issued by the Village of Greenview, Menard County, Illinois.
